All documents are with the Government and these are out for public consultation. At the end of February a decision should be made. The election of a Mayor for Norfolk and Suffolk should be held in 2026.

There was funding for new bus stops and this was discussed again. Peter Neatherway would review the suggested location however, this would depend on Highways, land access and visual splay regulations. Discussion also took place on the additional 3,000 homes in North Walsham and how that would affect the area.
